Hayman was born on October 10, 1956 in Flint, Michigan. His life was a testament of faith, justice and unwavering commitment to his family and community throughout his distinguished career. Judge Hayman dedicated himself to upholding the law with integrity and compassion, leaving an indelible impact on those he served. Beyond the courtroom, he was a loving husband, a caring father, a cherished friend and a pillar of wisdom and strength. While his physical presence will be deeply missed, his legacy of fairness, kindness, and faith will live on in the hearts of all who knew him. We take comfort in knowing that he now rests in the loving arms of the Lord. Judge Hayman was raised in Flint and was a proud graduate of Flint Northwestern High School where he completed his studies on June 21, 1974. His pursuit of education and justice led him to Mott

Community College, followed by the University of Michigan, where he further honed his passion for the law. Determined to serve his community through the legal system, he continued his studies at the Detroit College of Law, earning his law degree. Beyond his professional accomplishments, Archie found great joy in life's adventures. He had a passion for riding his Harley-Davidson motorcycles. Traveling with his wife and family was his greatest joy, as he loved discovering new experiences and making cherished memories along the way. A devoted reader, Archie was especially passionate about the Bible, drawing wisdom and guidance from its teachings throughout his life. His faith was a cornerstone of his character, shaping the way he lived and served others. He was also an avid movie lover, enjoying films that entertained, inspired, and sparked meaningful conversations with those around him.
