June 16, 1917 - January 5, 2014

BRADLEY, Mr. Clinton - Age 96, passed away Sunday, January 5, 2014 at his residence. Family hour 1:30 p.m. Saturday, January 11, 2014 from the Chapel of Lawrence E. Moon Funeral Home, 906 W.
