Mr. Matthew Scott was born March 2, 1935 in Jonesville, Louisiana, the son of Samuel A. Scott, Sr. and Alice Steward-Scott. Mr. Scott was raised in Elaine, Arkansas. He was baptized and accepted Christ at an early age. Mr. Scott joined the U.S. Army, after returning home, he relocated to Flint, Michigan. There he married his now deceased wife, Delores Harris-Scott. He worked for Flint Metal Fabricating, a division of General Motors for 36 ½ years, retiring in May of 1991 and was a member of UAW Local #659.
