Attorney Mya L. Marshall was born and raised in Flint, Michigan. Mya was the daughter of Billy and Wanda (Simmons) Marshall. Even in high school, Mya earned recognition at local and state levels for her volunteerism and community involvement including Proclamations from the Michigan House of Representatives, Senate and the Proclamation of "Mya L. Marshall Day" In the City of Flint, Michigan.

After High School, Mya matriculated at Central Michigan University, earning her Bachelor of Science degree majoring in Biology and Political Science with an concentration in Public Administration. She also earned her Masters of Science in Administration degree, maintaining an 4.0 GPA, from Central Michigan University. Subsequently, Mya was inducted into Golden Key International Honor Society.

Mya went on to earn her Juris Doctorate from Thomas M. Cooley Law School.

While attending Cooley, Mya participated in Moot Court Board, BLSA, Moot Court and Client Counseling competitions. She represented Cooley as a board member for the State Bar of Michigan Law Student Section and participated in the Estate Planning Clinic.

A Multi-tasker, Mya worked full time as an Medical Laboratory Technologist Lead Instructor for the American Red Cross while attending Law school. Mya previously worked for the Detroit Crime Laboratory as an Forensic Technician.

During her tenure with the Detroit Crime Laboratory, Mya was court-qualified as an expert witness.

In late 2011, Attorney Marshall, founded the Law Offices of Mya L. Marshall, P.L.L.C. in Detroit Michigan. The mission of the Law Offices of Mya L. Marshall, P.L.L.C. is to provide professional, client-responsive legal services and to establish a reputation as an engaged emissary of legal information to the public.

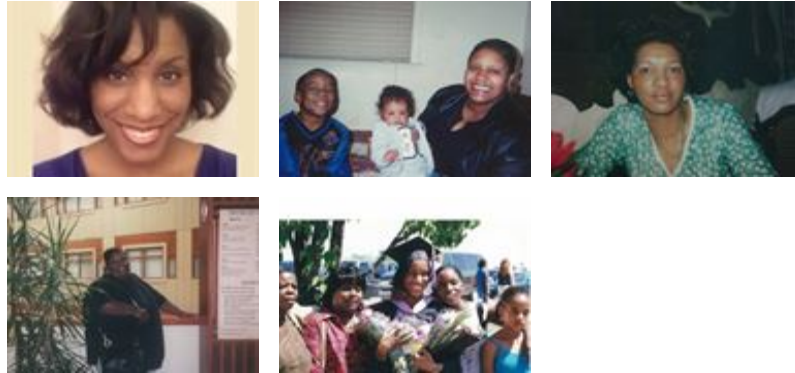
