PETROSS-BUCKNER, Atty. Precious Doris - Age 102, passed away Monday, September 29, 2025, in Marietta, GA. Zeta Phi Beta Sorority, Inc., service at 9:30 AM with family hour at 10:00 AM on Saturday, October 25, 2025, at Mt. Olive Missionary Baptist Church, 424 Kennelworth Ave., with funeral service commencing at 11:00 AM Pastor Jevon Catlett, officiating. Interment Great Lakes National Cemetery, G-4200 Belford Rd., Holly, MI. Friends and pallbearers will assemble at the church 10:00 AM Saturday. Atty. Buckner will lie in state in the Chapel of Lawrence E. Moon Funeral Home, 906 W. Flint Park Blvd., and may be viewed from 12:00 PM - 1:00 PM Friday.

Attorney Precious Doris Petross Buckner was born on January 27, 1923, in Chicago, Illinois, to Olive Williams. She was lovingly raised by her grandparents, Charlie and Fannie Williams, and later moved to River Rouge, Michigan. Precious was a proud graduate of River Rouge Elementary and High School, Wayne University, the University of Michigan (B.A.), Eastern Michigan University (M.A.), and Detroit College of Law (now Michigan State University College of Law), where she earned her Juris Doctor.

In 1942, she married Robert Glenn Petross, with whom she had four children: Charles Howard, Janice Elaine (AnNisa), Michael Alan, and Mildred Louise. The family settled in Romulus, Michigan. Tragically, youngest daughter Mildred was lost in a car accident at age five.

In 1955, following her marriage to James Clark, Precious moved to Flint, Michigan, where a son was born but passed shortly after birth. In Flint, Precious and her children became devoted members of Mt. Olive Missionary Baptist Church, serving faithfully for over 65 years.

A true trailblazer, Precious, broke numerous barriers in her professional career. She became the first Black and female Personnel Technician for the City of Flint, Michigan; the first Black and female Personnel Manager of Hurley Medical Center in Flint; and the first Black and female Personnel and Labor Relations Director of Hurley Medical Center in Flint. In 1985, Precious retired from Hurley as the first Black female Assistant Medical Center Director for Human Resources and Employee Health and Education. After retirement, she continued to serve her community as a Staff Attorney for UAW GM Legal Services and later as a labor mediator.

Precious was a dedicated civic leader. She served as President of the Y.W.C.A. of Greater Flint, sat on the National Board of Directors for the Girl Scouts of America, and was recognized with numerous awards including: the Nina Mills Woman of Achievement Award from the Greater Flint Y.W.C.A., and the Genesee, Lapeer, and Shiawassee Chapter of Women Lawyers Association of Michigan named her the Woman of the Year. Precious was also selected to be one of 50 Flint women for a photographic celebration entitled Women of a New Tribe at the Flint Institute of Arts. She was also a life member of the National Association of Negro Business and Professional Women Clubs.

Precious joined Zeta Phi Beta Sorority, Inc. in 1941, beginning a lifelong legacy of sisterhood and service. Her legacy in Zeta Phi Beta was especially dear to her heart. A charter member of the Zeta Beta Zeta alumni chapter in Flint, MI. Precious also chartered a Zeta Phi Beta chapter at Wayne State

University, one of the first in Michigan. Precious also shared a special friendship with Frances Faithful, daughter of one of the Sorority's Founders. A milestone moment came when she proudly pinned her granddaughter Aminah during her Zeta Phi Beta induction, continuing the family tradition as a Legacy. Although the pandemic disrupted her plans to attend Zeta Phi Beta's Centennial Boule in 2020, Precious and Aminah later attended the 2022 national convention in Philadelphia together.

Later in life, Precious moved to Detroit to live with her son Michael, and then to Atlanta, Georgia, where she celebrated her 100th birthday surrounded by loved ones. Her centennial celebration in Flint, hosted by Zeta Phi Beta at the newly renovated Flint Public Library, drew hundreds of well-wishers and over 300 birthday cards, turned into a striking "100" collage.

Back in Atlanta, she was surprised with her second 100th birthday celebration attended by local dignitaries, Zeta sisters, and filled with southern hospitality. She received resolutions and honors from President Joe and First Lady Jill Biden, the Governors of Michigan and Georgia, U.S. Senators, the Mayor of Austell, Georgia, and a special Centenarian of the Year plaque from the Valley Area Agency on Aging.

Precious lived to celebrate both her 101st and 102nd birthdays, surrounded by generations of family, who marveled at her strength, wisdom, and the incredible legacy she built.

Precious is survived by: her son Charles (Bucilla), (9) grandchildren: Natalie (Danny), Aminah (Ibrahim), Melanie (Anthony), Mikhail, Nurah, Umar, Sakinah, Tariq (Euriel), and Mansur (Layla), (34) great-grandchildren, (13) great-great grandchildren, and several godchildren. Precious was preceded in death by her husbands: Robert Petross, James Clark, and Robert (Bob) Buckner, her beloved children: daughters, Janice (AnNisa) and Mildred, and

her son Michael (Phil).

The family extends special thanks to Reverend Jevon Q. Catlett of Mount Olive Missionary Baptist Church, the devoted staff at her care facility, and the sisterhood of Zeta Phi Beta Sorority, Inc. for their lifelong support and love.

Precious Doris Petross Buckner lived an extraordinary life of service, leadership, and grace. Her legacy will continue to inspire generations to come.

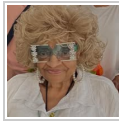
