SMITH, Atty. William D. " Bill" Sr. - Age 68, passed away Thursday, August 15, 2019 at his residence. Family hour 10:00 AM Friday, August 23, 2019 at Mt. Olive Baptist Church, 424 Kennelworth Ave., with funeral service commencing at 11:00 AM. Pastor Jevon Catlett, officiating. Interment Flint Memorial Park, G-9506 N. Dort Hwy., Mt. Morris, MI. Friends and pallbearers will assemble at the church 10:00 AM Friday. Atty. Smith will lie in state in the Chapel of Lawrence E. Moon Funeral Home, 906 W. Flint Park Blvd., and may be viewed 2:00 PM - 8:00 PM Thursday. Attorney William "Bill" D. Smith was born September 14, 1950 in Indianapolis, IN to Mary M. Holland and Thomas D. Smith. Bill, affectionately referred to as Smitty, moved to Flint, MI where he attended Clark Elementary, Whittier Junior high, and Southwestern High school and was a track star. Bill graduated from the Flint campus of the University of Michigan. Bill worked as a nurse's assistant and physical therapist while being a full time student at U of M. He worked in physical medicine at Hurley for many years before deciding to go back to school to pursue his passion in law. Bill graduated with distinction in September 1984 as a member of the Randolph Manning Class at Thomas M. Cooley Law School. Not only did Bill graduate with distinction, but he scored highest on the bar in the State of Michigan. At graduation, he was presented with the Alumni Distinguished Student award. Bill was a devoted student and his hard work continued throughout his life. Bill started his private practice where he focused on personal injury, employment, civil rights and estate planning. Prior to

returning to private practice, he was general counsel for Hurley Medical Center for almost 30 years and Executive Vice President and General Counsel for over 15 years. He was highly respected by his colleagues, well-liked and left a positive lasting impression on everyone who had the pleasure of meeting him. Bill's gifts didn't stop there. He was a prominent figure in the community as well. He gave back tirelessly to his community with a humble heart. He was a current chair on the board of directors for Greater Flint Big Brothers Big Sisters and Genesee County since 2014. Past president of Mallory Scott Van Dyne Bar Association (Black Bar Association of Genesee County). Past Vice President, Board of directors of Michigan Society of Hospital Attorneys, member of the Thomas M Cooley Donor Recognition Society, Past secretary, Board of directors for Genesee County Bar Association, Gold life member of the NAtACP, and lifelong member of Mt. Olive Baptist Church where he served on the Trustee Board & Finance Committee. A few of his accolades includes being the recipient of Genesee County Bar Association most prestigious award "The Herbert Milliken, Jr. Civility Award", the Dr. Martin Luther King Jr. Scholarship, the Distinguished student Award at Cooley Law School, Herbert Milliken, Jr. Civility Award, and the Whos Who Award (years), as well as being an active member of several organizations including the American Bar Association, Michigan Society of Health Care Risk Management Board Member, Michigan Society of Health Care Attorneys Board Member, T. 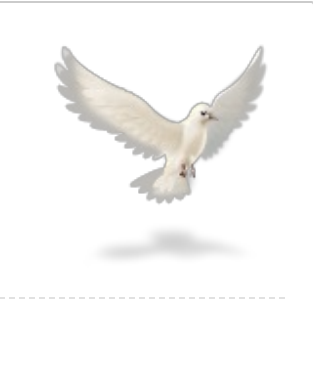
